BAC Letter	 Feedback and Recommended Edits to the <u>BAC Draft</u> <u>Letter:</u> Commissioner Linn: 5% cut is well stated but would describe it as "practical" vs "equitable". Instead of reinstating the Grant funding for E. Portland would it be better to apply it to the Add Package – reduce the Add Package amount. Commissioner Stevenson: 5% cut across the bureaus is "equal" not "equitable". Suggests saying "While it feels equal, it does not have an equitable impact on the people that we are all prioritizing right now.". Commissioner Fonseca: Housing has been a priority for many years, a cut here is not reflecting that priority. Commissioner Stevenson: Where it talks about COVID disparities on BIPOC Communities – include Housing to add a double layer of disparities on BIPOC Communities. Preference Policy support paragraph: Commissioners agreed to leave the paragraph in. Commissioner Stevenson recommended making the connection between Economic stability, jump starting the economy and the commitment to DMWESB and the community.
