

ORDINANCE No. 149800

An Ordinance amending Ordinance No. 149056, being an ordinance assessing upon certain property the cost of repairing and constructing sidewalks, curbs and driveways in front thereof for the one-month billing period ended October 31, 1979 by reducing the assessment for Carson Heights, Block 9, Lot 7, and reducing the total assessment by \$65.23, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 149056 assessed Carson Heights, Block 9, Lot 7, \$361.13 for repair and construction of sidewalks, curbs and driveways in front thereof for the one-month billing period ended October 31, 1979, and entered in City Lien Docket Book 124, Page 137.
2. The original posting for this work was in error and the property was over-charged for sidewalk construction.


NOW, THEREFORE, the Council directs:

- a. Ordinance No. 149056 is amended by reducing the assessment against Carson Heights, Block 9, Lot 7, by \$65.23 and reducing the total assessment of \$33,272.77 to \$33,207.54.

Section 2. The Council declares that an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
