ORDINANCE No. 149818

An Ordinance authorizing a contract with Bronco Northwest Inc., in the amount of \$25,963. to furnish Steel shelving, Cantilever racks, Pallet racks to the Bureau of Maintenance, authorizing the drawing and delivery of a warrant and declaring an emergency.

The City of Portland, Ordains:

Section 1. The Council finds:

- 1. Bronco Northwest Inc., was the lowest responsible bidder for Steel shelving, Cantilever racks, and Pallet racks, for the Bureau of Maintenance.
- Award of a contract to said bidder for furnishing said item has been recommended and approved by the Commissioner in charge.

NOW, THEREFORE, the Council directs:

- a. The <u>Administration</u> of Public Works and the Auditor are authorized to execute a contract with the responsible bidder for the item described in Section 1. hereof in accordance with specifications filed with the purchasing agent on April 16, 1980.
- b. The Mayor and the Auditor hereby are authorized to draw and deliver a warrant chargeable to the 1979-80 budget. General Fund, Bureau of Maintenance, RU 168, BUC 16800023.642 when demand is presented, approved by proper authorities.
- Section 2. The Council declares that an emergency exists because a delay in proceeding with the purchase may result in additional expense, and will unnecessarily deprive the City of the benefits of completion of the contract at an early date; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
