ORDINANCE No. 149831

An Ordinance authorizing a Contract with Triad Construction Inc. to construct a concession stand and restrooms at Portland International Raceway for the sum of \$62,978 for the Bureau of Parks, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The Purchasing Agent has advertised and received proposals for construction of a concession/restroom facility for the motocross area of Portland International Raceway, said bids being opened June 17, 1980.
- 2. Triad Construction Inc. of Wilsonville, Oregon was the lowest responsive bidder in the amount of \$62,978.
- 3. Award of a contract to said bidder for completing said project has been recommended and approved by the Commissioner-in-Charge.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Affairs and the Auditor hereby are authorized to enter into a contract with Triad Construction inc. for the project described in Section 1 hereof in accordance with specifications filed with the Purchasing Agent on April 3, 1980.
- b. The Commissioner and Auditor hereby are authorized to draw and deliver warrant(s) chargeable to the 1979-80 Budget; General Fund, Bureau of Parks, Revenue Facilities, RU 137, Object Code 630, Improvements, when demand is presented, approved by the proper authorities.
- Section 2. The Council declares that an emergency exists because delay in proceeding with this contract may result in additional expense to the City and will unnecessarily deprive the City of the benefits of completion of the contract at an early date; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
