

## ORDINANCE No. 149842

An Ordinance transferring \$45,373 within the General Fund from General Operating Contingencies to the Bureau of Parks, AU 130, for ash cleanup related expenditures, and declaring an emergency.

The City of Portland ordains:

Section I. The Council finds:

1. The Bureau of Parks and Recreation requires \$45,373 additional in its 1979-80 budget for ash cleanup overtime and materials and services expenditures.
2. Due to the Mt. St. Helens volcanic eruption on June 12, 1980 volcanic ash accumulated in the Portland area. Its immediate removal and cleanup were necessary for the health and safety of Portland residents.
3. Ash cleanup related expenditures for assisting Public Works crews and clearing Bureau of Parks parking lots through June 30, 1980 are estimated at \$45,373 by the Bureau of Parks.
4. The appropriation of \$45,373 for overtime and Materials and Services expenditure should be provided by transfer from General Operating Contingencies to the Bureau of Parks 1979-80 budget.

NOW, THEREFORE, the Council directs:

- a. \$45,373 is transferred within the General Fund from General Operating Contingencies (RU 201) to the Bureau of Parks (AU 130) 1979-80 budget as follows:


