

ORDINANCE No. 149845

An Ordinance transferring \$134,510 within the Bureau of Maintenance budget, and declaring an emergency.

The City of Portland Ordains:

Section 1. The Council finds:

1. An emergency situation exists due to eruption of Mt. St. Helens on June 13, 1980.
2. The Bureau of Maintenance has incurred extraordinary overtime expenses relating to removal of volcanic ash.
3. The emergency response by the Bureau of Maintenance to reduce ash in the City of Portland on the June 13th weekend expenses were \$261,860, including \$216,580 as marginal expense.
4. Additional marginal expenditures between June 18, 1980 and July 3, 1980 for equipment rental and overtime is anticipated to be \$364,600.


NOW, THEREFORE, the Council directs:

- a. The FY 79-80 City budget is hereby amended to change appropriations as follows:

Section 3. The Council declares that an emergency exists because of the disabling effect of the ash fallout; that appropriations are needed in the accounts to which they are to be transferred; and that payments should be authorized; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
