

**ORDINANCE No. 149852**

An Ordinance authorizing the acceptance of a U.S. Economic Development Administration 302(a) grant amendment in the amount of \$35,000; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The U.S. Economic Development Administration makes available grants in aid of economic planning.
2. Ordinance No. 147596 authorized the application for a 302(a) economic planning grant from the U.S. Economic Development Administration, which was awarded in the amount of \$90,000.
3. The U.S. Economic Development Administration has now offered an amendment to this grant in the amount of \$35,000 to the City of Portland in support of CEDS coordination activities carried out by the Bureau of Economic Development.
4. Total project cost for the grant amendment is \$46,667. Local match of \$11,667 is required and can be provided by in-kind match. The grant includes indirect costs of \$1,707.

NOW, THEREFORE, the Council directs:

- a. The Mayor of the City of Portland is authorized to accept a grant amendment in the amount of \$35,000 from the U.S. Economic Development Administration and to provide other grant information and assurances as may be required by the grant amendment agreement.

Section 2. The Council declares an emergency exists because delay in acceptance may result in loss of opportunity to fulfill necessary CEDS coordination and economic planning functions; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
