

ORDINANCE No. 149853

An Ordinance authorizing the transfer of \$20,000 within the General Fund, Bureau of Buildings (AU 520) from Personal Services to Materials and Services in order to cover FY 79-80 expenditures; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That savings have been identified within the Personal Services major object category.
2. That the appropriation within the Materials and Services major object category is not sufficient to cover proposed expenditures.
3. That appropriations should be transferred from Personal Services to the Materials and Services major object category.

NOW, THEREFORE, the Council directs:

- a. That the 1979/80 City budget is amended to revise appropriations within the Bureau of Buildings as follows:
