

ORDINANCE No. 149856

An Ordinance amending the FY 79-80 budget for the Civic Stadium by transferring \$49,000 within the Exposition-Recreation Fund from General Operating Contingency to the Civic Stadium, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Civic Stadium has incurred expenses for out-of-town travel and capital equipment which exceed the amounts anticipated in the FY 79-80 budget.
2. Additional appropriation for the Civic Stadium should be provided by transferring \$49,000 within the Exposition-Recreation Fund from General Operating Contingency to the Civic Stadium, Out-of-Town Travel, \$100, and Furniture and Equipment, \$48,900.


NOW, THEREFORE, the Council directs:

- a. The FY 79-80 budget for the Civic Stadium is hereby amended as follows:

From:	Exposition-Recreation Fund	
	General Operating Contingency (19910008)	\$49,000
TO:	Civic Stadium (19800016)	
	430 Out-of-Town Travel	\$ 100
	640 Furniture and Equipment	48,900

Section 2. The Council declares that an emergency exists because the appropriation is needed immediately in the account(s) to which it is to be transferred, so that there may be no program interruption or administrative delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
