

ORDINANCE No. 149857

An Ordinance amending the FY 1979-80 budget for the Memorial Coliseum by transferring appropriations of \$107,000 between major object classes and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Memorial Coliseum has incurred expenses for overtime and materials and services in excess of the amounts anticipated in the FY 1979-80 budget.
2. The additional appropriation required should be provided by a transfer within the Memorial Coliseum budget from personal services and capital outlay to materials and services.

NOW, THEREFORE, the Council directs:

- a. The FY 1979-80 budget for the Memorial Coliseum (200) is hereby amended as follows:
