ORDINANCE NO. 149860

An ordinance authorizing a compromise settlement in the amount of \$7,500 to be paid to claimant Milton R. Stewart for personal injuries resulting from a search of his law office, and subsequent seizure of materials from said office by Portland police officers on October 10, 1979, subject to the approval of the Multnomah County Circuit Court, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Milton R. Stewart, who maintains his law office at Suite 500, 813 S. W. Alder Street, Portland, Oregon, has made a claim for \$100,000 for personal injuries resulting from a search of his offices and subsequent seizure of materials therefrom by the Portland police on October 10, 1979.
2. The Commissioner of Finance Administration, the City Attorney, and the law firm retained by the City to handle this matter all recommend that the claim be settled for \$7,500, subject to claimant providing the City a release in a form to be approved by the City Attorney.
3. Pursuant to ORS 30.290, the settlement of this claim is subject to the approval of the Multnomah County Circuit Court.

NOW, THEREFORE, the Council directs:

- a. Subject to the approval of the Multnomah County Circuit Court pursuant to ORS 30.290, the Mayor and Auditor are authorized to draw and deliver a warrant in the amount of \$7,500 made payable to Milton R. Stewart and John J. Haugh, his attorney, as settlement in full of all claims for damages upon receipt of a release approved by the City Attorney.

ORDINANCE No.

Section 2. The Council declares:

That an emergency exists in order that payment of attorneys' fees and other associated costs in a condemnation action instituted by the City may be paid without undue delay; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
