

ORDINANCE No. 149862

An Ordinance authorizing the Purchasing Agent to call for bids for redevelopment of McKenna Park as part of a grant from the Department of the Interior, authorizing a contract, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Parks requires redevelopment of McKenna Park as part of their Urban Parks and Recreation Recovery Grant from the Heritage Conservation and Recreation Service entitled "Portland Parks Rehabilitation Project I", Grant Number 41 CTY 1650-79-01.
2. Park Bureau will file an ordinance appropriating the grant resource as soon as Council adopts the 1980-81 Budget.

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall advertise for bids using plans and specifications prepared by the firm of John Warner and Associates, and filed in the Purchasing Agent's office by the Bureau of Parks. In the event no satisfactory bid is received, the Purchasing Agent shall readvertise on the same specifications until a satisfactory bid is received.
- b. A contract is authorized with the most favorable bidder as designated by the Council.
- c. The Mayor and the Auditor hereby are authorized to draw and deliver warrants when demand is presented approved by the proper authorities.

Section 2. The Council declares that an emergency exists because delay would jeopardize the completion of the project; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
