

# ORDINANCE No. 149863

An Ordinance transferring \$55,000 within the Bureau of Parks 1979-80 Budget from Personal Services to Overtime Object Code and Materials and Services, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Parks requires \$55,000 additional appropriation in overtime Object Code and Materials and Services category to prevent over-expenditure.
2. Clean-up of 1980 ice storm damage caused delays in normal expenditures which resulted in expenditures in the 4th Quarter beyond revised estimates.
3. The required appropriation can be provided by transfer within the Bureau of Parks Budget from savings in the Personal Services major category.
4. Transfer of \$55,000 within the Bureau of Parks from Personal Services to Overtime Object Code and the Materials and Services category should be made.

NOW, THEREFORE, the Council directs:


- a. \$55,000 is transferred within the Bureau of Parks 1979-80 Budget as follows:
