An Ordinance purchasing one oil painting from Harry Widman in the amount of \$1000; one oil painting from Hank Kowert in the amount of \$800; and one oil painting from Melinda Thorsnes at \$700; authorizing contracts and the drawing and delivery of warrants; and declaring an emergency.

The City of Portland ordains:

1

Section 1. The Council finds:

- 1. That the City of Portland and Multnomah County have established the Metropolitan Arts Commission in order to further the development and public awareness of, and interest in, the performing and visual arts.
- 2. That the City has chosen one painting from Harry Widman, Hank Kowert and Melinda Thorsnes for the Metropolitan Arts Commission Visual Arts in Public Places collection.
- 2. That appropriation exists withing the bureau fiscal year 1979-80 budget for this purpose.

Now THEREFORE, the Coucil directs:

- a. The Auditor and Commissioner of Public Affairs to execute on behalf of the City a contract similar inform to Exhibit "A' with Harry Widman of 117 NW 21st, Portland Or, 97205, Exhibit "B" with Hank Kowert of 1017 SW Morrison, Rm 205, Portland, Or., 97205 and Exhibit "C" with Melinda Thorsnes of 2190 W.
