

ORDINANCE No. 149870

An Ordinance amending Ordinance No. 149556 to correct transfer from Unforeseen Reimbursable Expenditures to General Fund Contingency, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Pursuant to Ordinance No. 149556, approved by Council May 7, 1980, the FY 1979-80 City Budget was amended by transferring \$25,250 from the Human Resources Bureau, AU 380, to Unforeseen Reimbursable Expenditures.
2. Pursuant to a call from Financial Affairs, the funds should have been transferred to the General Fund Contingency.
3. It is therefore appropriate to amend Ordinance No. 149556 by correcting the transfer from Unforeseen Reimbursable Expenditures to the General Fund Contingency.

NOW, THEREFORE, the Council directs:

- a. That Ordinance No. 149556 is hereby amended by correcting the transfer from Unforeseen Reimbursable Expenditures to the General Fund Contingency.


