ORDINANCE No. 190323

* Pay settlement of Estate of Quanice Hayes wrongful death lawsuit in the sum of \$1,500,000 plus costs of \$595,081 involving the Portland Police Bureau (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Estate of Quanice Hayes, through attorney J. Ashlee Albies, has filed a lawsuit against the City regarding an officer involved shooting on Thursday, February 9, 2017.

2. The lawsuit has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the lawsuit at this time.

3. Risk Management Services recommends the lawsuit be compromised for the total sum of \$1,500,000 plus costs of \$595,081, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$1,309,387.46 payable to Albies & Stark, LLC and their client Venus Hayes.

b. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$785,693.54 payable to MetLife Assignment Company, Inc. to fund the structured settlement. **Introduced by** Mayor Ted Wheeler
