I've lived at Hazelnut Grove since 2015.

My partner and I lost housing when our building was sold.

We lived in our van for 2 years.

When we found the Hazelnut site we camped and joined with other residents and many neighbors and organizations building our tiny homes.

Since living at Hazelnut, I've been able to take care of many health needs and gotten social security.

I even have checking and savings accounts.

I couldn't get these things accomplished living on the streets. Here I've found the stability and calm I needed to move ahead with my life.

I deal with bipolar and panic disorders, but here I've gotten the calm to be more out in the world. A stable home is necessary to me to keep going on my path.

I may not always be here, but Hazelnut Grove has sure worked for me.

The residents and their community friends have completed an RFPQ and submitted it, to establish the rights of the residents to remain in their homes. We ARE grateful for the suspension of your plans to demolish the village fencing and cabins. We also understand that the village is NOT comparable to other unsanctioned camps around the city; it is an organized self-managed community which needs the status of permanence so that residents can continue to advance with the projects they've planned to improve their physical surroundings and, more importantly, the peace and stability all people need to make progress in their individual lives.
