ORDINANCE NO. 149883

An Ordinance transferring \$5,700 within the 1979-80 budget of the Bureau of Facilities Management from personal services and capital outlay to materials and services, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That, because of unplanned and unbudgeted expenditures related to repairs at Kelly Butte and Police Headquarters and to the minor remodelling of the Mayor's office, the materials and services appropriation of the 1979-80 Bureau of Facilities Management budget may be insufficient.
- 2. That savings in the amount of \$5,700 exist within the personal services and capital outlay object codes and are available for transfer.
- 3. That in order to remain in compliance with the Local Budget Law, an appropriation transfer is necessary.

NOW, THEREFORE, the Council directs:

a. \$5,700 is transferred within the 1979-80 budget of the Bureau of Facilities Management as follows:
