

ORDINANCE No. 149884

An Ordinance repealing Ordinance No. 149728 and creating one position of Battalion Chief/Assistant Fire Marshal, abolishing one position of Fire Marshal in the Bureau of Fire, AU (124), revising the current compensation plan to reflect the above changes effective June 27, 1980 and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That Ordinance No. 149728 creating one position of Assistant Fire Marshal with a flat salary rate of \$16.25 should be repealed.
2. That one (1) position of Battalion Chief/Assistant Fire Marshal is required within the Bureau of Fire, Prevention Division, effective June 27, 1980.
3. That the existing position and title of Fire Marshal can be abolished as a result of this action.
4. That the position being created and the position being abolished have the same salary rate.
5. That the Bureau of Personnel Services has reviewed and approved this action effective June 27, 1980.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 149728 is repealed.
- b. The position of Battalion Chief/Assistant Fire Marshal is created in the Bureau of Fire, Prevention Division, with a salary rate in accordance with the existing compensation plan.
- c. The position of Fire Marshal (5224) is abolished within the Bureau of Fire, Prevention Division, effective June 27, 1980.
- d. The compensation plan will be revised to delete the old position title of Fire Marshal.

Section 2. The Council declares that an emergency exists because the repealing of Ordinance No. 149728 and the position being created are required in order that the functions of the Bureau of Fire may be carried out without delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
