

ORDINANCE NO. **149885**

An Ordinance authorizing an application to the United States Fire Administration for a grant estimated at \$15,000 to support the participation in Phase II of Project FIRES, authorizing a contract, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The United States Fire Administration makes grants to local governments to support participation in the testing and evaluation of prototype protective clothing for fire fighters developed under project FIRES (Firefighters Integrated Response Equipment System).
2. The Fire Bureau utilizes protective clothing in suppressing fires and could potentially improve fire fighting safety and effectiveness through participation in this program.
3. The project cost is estimated at \$18,500 of which \$3,500 will be provided as local share, which local share is available from existing appropriation within the FY 1980-81 Bureau of Fire approved budget. No indirect costs are allowable under the grant program.
4. Should the City receive the grant, it will be obligated to comply with the regulations of the United States Fire Administration.

NOW, THEREFORE, the Council directs:

- a. The Commissioner-in-charge shall make application to the United States Fire Administration for a grant of \$ 15,000 in aid for the testing and evaluation of prototype protective clothing.
- b. Should the described grant be approved, a contract or grant agreement is authorized.
- c. The Commissioner-in-charge is authorized to provide assurances regarding the use of the grant as may be required by the United States Fire Administration
- d. The Commissioner-in-charge is authorized to provide such information and assurances as are required for receipt, expenditure, and accounting for the grant project.

- e. Expenditures under the grant are not authorized until the United States Fire Administration has approved the grant; the Council has specifically appropriated the funds, and the system of accountability has been established by the Bureau of Financial Affairs.

Section 2. The Council declares that an emergency exists because regulations governing the grant application require immediate application, and delay in application may result in the loss of opportunity to receive the grant; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
