

ORDINANCE No. 149896

An Ordinance transferring \$80,000 within the Sewage Disposal Fund from Sewage Disposal Contingency, and Bureau of Wastewater Treatment, to Bureau of Wastewater Treatment, Operate Secondary Treatment, Utilities, for additional unforeseen electrical energy costs and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Wastewater Treatment requires \$80,000 additional within its budget for increased electrical energy costs.
2. That an unforeseen twenty percent increase in electrical energy costs for the Bureau of Wastewater Treatment was not included in the 1979-80 Budget.
3. The additional appropriation should be provided by transfer within the Sewage Disposal Fund.

NOW, THEREFORE, The Council directs:

- a. The sum of \$80,000 is hereby transferred within the Sewage Disposal Fund as follows:



The Council declares that an emergency exists because the appropriation is needed immediately in the account to which it is to be transferred, so that there may be no program interruption or administrative delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
