- 2. Since the 1980-81 Fiscal Year Budget was submitted and approved, an audit of the three positions has been completed and the Civil Service Board determined the classification and title of the three positions to be Water Engineer Supervisor, Class No. 3177.
- 3. The salary rates for the Water Engineer Supervisor positions have been approved at the same rate of compensation as the Supervising Engineer positions approved in the 1980-81 Fiscal Year Budget by the Bureau of Personnel Services.




