An Ordinance authorizing application by the Bureau of Parks to the Oregon
State Marine Board for a grant estimated at \$76,442.00 for reconstruction
of the existing boat ramp at Willamette Park, and declaring an
emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Oregon State Marine Board makes grants to local governments for the construction and improvement of boating facilities and related projects.
- 2. The boat ramp at Willamette Park has deteriorated to an unsafe condition due to erosion of its underwater portion.
- 3. The grant application will request funds for Phase II of the project in the amount of \$76,442.00 for construction of the boat ramp. Full indirect costs at a rate of 10 percent of eligible costs are included in the grant budget.
- 4. The grant requests that the State Marine Board fund 50% of the project. Should it be approved, City of Portland general funds would be requested for the remainder of the project.

NOW, THEREFORE, the Council directs:

- a. The Mayor and Commissioner-in-Charge shall make application to the Oregon State Marine Board for a grant estimated at \$76,442.09 for reconstruction of a boat ramp at Willamette Park.
- b. Should the described grant be approved, a contract or grant agreement is authorized.
- c. The Commissioner in Charge is authorized to provide assurances regarding the use of the grant as may be required by the Oregon State Marine Board.
