An Ordinance authorizing the appointment of Dennis L. Van Lear-Harper to the position of Legal Secretary at a rate higher than the entry rate, effective June 25, 1980, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- (1) The Office of City Attorney has a Legal Secretary vacancy. Dennis L. Van Lear-Harper has experience and skills and will have supervisory responsibilities that justify his appointment as a Legal Secretary at a rate of after two years with an increase to the rate provided after three years upon completion of a year's service.
- (2) The Office of City Attorney has sufficient funds budgeted to allow filling the vacancy.

NOW, THEREFORE, the Council directs:

- (a) The Office of City Attorney may fill its vacant Legal-Secretary position by appointing Dennis L. Van Lear-Harper at a rate of after two years, effective June 25, 1980, with an increase to the rate after three years upon completion of a year's service.
- Section 2. The Council declares that an emergency exists because creation of the new position is necessary in order to properly compensate the individual in the Office of City Attorney based on his skill and experience and on the duties and responsibilities assigned; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
