

**ORDINANCE No. 149918**

An Ordinance setting aside the Bureau of Water Works System Development Charge for four 3/4" water services to be used for landscaping irrigation on the Union Avenue Improvement Project on N.E. Union Avenue between N.E. Columbia Blvd. and N.E. Weidler Street.

The City of Portland ordains:

Section 1. The Council finds:

1. Four 3/4" water services for landscaping irrigation are required, on the Union Avenue Improvement Project, to be installed between N.E. Columbia Blvd. and N.E. Weidler Street on N.E. Union Avenue.
2. The State of Oregon, Department of Transportation, indicates the Federal Highway Administration refuses to pay the System Development Charge to the Bureau of Water Works established by Ordinance No. 147704 and revised by Ordinance No. 148709.
3. The Bureau of Streets and Structures recommends the System Development charge to be set aside for the four water services referred to herein.

NOW, THEREFORE, The Council directs:

- a. The Bureau of Water Works shall not require payment of the System Development Charge for four 3/4" water services to be used for landscape irrigation on the Union Avenue Improvement Project to be installed on N.E. Union Avenue between N.E. Columbia Blvd. and N.E. Weidler Street.
