ORDINANCE NO. 149950

An Ordinance accepting a street deed right of way for the SE Umatilla Street West of SE Grand Avenue Street Improvement Project granted by F & L Development Company, and declaring an emergency.

The City of Portland ordains:

### Section 1. The Council finds:

- 1. Right of way is required for construction of the SE Umatilla Street West of SE Grand Avenue Street Improvement Project.
- F & L Development Company has conveyed the required right of way to the City at no cost to the City.

## NOW, THEREFORE, the Council directs:

a. That the following described tract is hereby accepted for street purposes:

A portion of vacated SE Umatilla Street contiguous with the south line of Block E in the duly recorded plat of "Sellwood" situated in the southeast one-quarter of Section 22, TlS, RlE, W.M., in the City of Portland, County of Multnomah, and State of Oregon, more particularly described as follows:

Beginning at the southeast corner of said Block E "Sellwood"; thence S.24°42'12"E. along the southerly extension of the easterly line of said Block E, a distance of 27.88 feet to a point in a line parallel with and 25.00 feet south of (when measured at right angles to) the north line of said vacated SE Umatilla Street; thence N.88°25'07"W. parallel with said north line, a distance of 65.00 feet to a point; thence N.1°34'53"E. a distance of 25.00 feet to a point in the south line of said Block E; thence S.88°25'07"E. along said south line, a distance of 52.65 feet to the point of beginning. (Granted by F & L Development Company, c/o Linda Triplett, 1331 SW Broadway, Portland, Oregon 97201).

b. The Auditor shall record in the appropriate deed records, documents of title as necessary for acquisition of this right of way.
