ORDINANCE No. 149963

An Ordinance amending Ordinance No. 149134, being an ordinance assessing upon certain property the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended October 31, 1979, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 149134 assessed Lot 3, except the W 40 ft. of S ½ & Lot 4 except the W 40 ft., Block 57, Caruthers \$63.00; Lots 1 and 3, Block 1, Central Park East Portland \$75.00 and Lot 11, Block 1, Avery \$119.70; for the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended October 31,1979, and entered in the City Lien Docket Book 124, Page 142.
- 2. The current owners of Lot 3, except the W 40 ft. of S½ & Lot 4, except the W 40 ft., Block 57, Caruthers; Lots 1 and 3, Block 1, Central Park East Portland; and Lot 11, Block 1, Avery, had not been properly notified at the time the work was done.

NOW, THEREFORE, the Councid directs:

- a. Ordinance No. 149334 is amended by cancelling the assessment against Lot 3, except the W 40 ft. of S½ & Lot 4, except the W 40 ft., Block 57, Caruthers \$63.00; Lots 1 and 3, Block 1, Central Park East Portland \$75.00; and Lot 11, Block 1, Avery \$119.70, and reducing the total assessment of \$6,409.85 to \$6,151.55.
- Section 2. The Council declares an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this Ordinance, shall be in force and effect from and after its passage by the Council.
