ORDINANCE No. 149979

An Ordinance amending Ordinance No. 149782, being an ordinance assessing upon certain property the cost of repairing and constructing sidewalks, curbs and driveways in front thereof for the one-month billing period ended April 30, 1980, by reducing the assessment for Beaumont, Block 29, Lot 11, by \$41.80; Westmoreland, Block 27, Lot 13 - \$110.00 and Sellwood, Block 65, W 35 ft. of Lot 1, by \$1.00; and reducing the total assessment by \$152.80, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- Ordinance No. 149782 assessed Beaumont, Block 29, Lot 11 \$459.80; Westmoreland, Block 27, Lot 13 \$426.91 and Sellwood, Block 65, W 35 ft. of Lot 1, \$165.78, for the repair and construction of sidewalks, curbs and driveways in front thereof for the one-month billing period ended April 30, 1980, and entered in the City Lien Docket Book 124, Page 234 237.
- 2. The assessment on Beaumont, Block 29, Lot 11 and Westmoreland, Block 27, Lot 13, were partially paid as invoices and should be reduced by \$41.80 and \$110.00, respectively. Sellwood, Block 65, W 35 ft. of Lot 1, was overcharged \$1.00 due to clerical error.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 149782 is amended by reducing the assessments against Beaumont, Block 29, Lot 11; Westmoreland, Block 27, Lot 13; and Sellwood, Block 65, W 35 ft. of Lot 1, by a total of \$152.80 and reducing the total assessment of \$21,417.74 to \$21,264.94.
- Section 2. The Council declares that an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
