- The existing five year contract for custodial services at the Water Services Building will expire on October 1, 1980.
- 2. The Bureau of Facilities Management requires a new five year contract for this service.

c. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the 1980-81 budget, General Fund, Bureau of Facilities Management, (BUC 34800294, Project 4028, Line Item 210, when demand is presented, approved by the proper authorities.

Section 2. The Council declares that an emergency exists because a delay in approval of this ordinance will impose an undue administrative burden upon the City; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
