ORDINANCE No. 149999

An Ordinance creating a temporary position in the Office of the Commissioner of Public Utilities, effective July 1, 1980, transferring \$10,700 within the General Fund.

Section 1. The Council finds:

- 1. That the citizens of Portland elected a new Mayor at the May, 1980 primary election, to take office on November 25, 1980.
- 2. That the Commissioner of Public Utilities requires additional temporary staff assistance to assure an effective transition between offices.
- 3. That the employment of a Commissioner's Assistant I for a period not to exceed six months from July 1, 1980, is adequate for this purpose.

NOW, THEREFORE, the Council directs:

- The following position is hereby created in the Office of the Commissioner of Public Utilities (192) with salary rates in accordance with the current compensation plan, effective July 1, 1980:
 - 1 0821 Commissioner's Assistant I

Section 2. The Council further directs that \$10,700 is hereby transferred from General Operating Contingency to the Office of the Commissioner of Public Utilities (19200019).
