ORDINANCE No. 150000

An Ordinance authorizing the City of Portland to waive certain street use fees required by Chapter 24.44 of the Code of the City of Portland relating to the City-County Justice Center project on Block 25, City of Portland.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City has entered into an agreement with the State of Oregon, Contract No. 18375, for construction of a City-County Justice Center on the Lenox Block, Block 25, City of Portland.
- 2. The costs of the project are to be divided between the public agencies, and such costs will include City permit fees.
- 3. The State project manager has requested that the City waive the fee for use of the public street as required by Chapter 24.44 of the Code of the City of Portland as it pertains to said project.
- 4. It is in the public interest to waive the street use fees for the Justice Center project since such fees will result in an additional financing cost burden for the public.

NOW, THEREFORE, the Council directs:

a. The street use permit fees required by Chapter 24.44 of the Code of the City of Portland are waived for the City-County Justice Center project that is being constructed on Block 25, City of Portland, by the State of Oregon.
