# ORDINANCE No. 150012

An Ordinance creating one position of Police Captain and abolishing one position of Police Lieutenant in the Bureau of Police, Office of the Chief, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That one position of Police Captain is required by the Bureau of Police to serve as a Command Coordinator.
- That the above position is necessary to reinstate nighttime command coordination for the Chief of Police and to maintain a continuity of operations in accordance with Bureau policy.
- 3. That said position was abolished in FY 78-79, but has since found to be important to regular police operations.
- That one position of Police Lieutenant can be abolished to provide partial appropriation for the position being created.
- That the necessary additional appropriation totaling \$1,676 will be provided within the Police Bureau's budget through salary savings accruing through FY 80-81.
- 6. That the position of Police Captain should therefore be created.

NOW, THEREFORE, the Council directs:

- a. That one (1) position of Police Captain (5138) is created in the Bureau of Police, Office of the Chief, with a salary rate in accordance with the current Compensation Plan and one (1) position of Police Lieutenant (5137) is abolished.
- Section 2. The Council declares that an emergency exists because the position to be created is immediately required in order that the new functions may be carried out without delay and the position to be abolished should not be continued unnecessarily; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
