An Ordinance amending Agreement No. 16394 with Mr. H.E. Howe, extending the contract period for one (1) year to provide consulting services for the Bureau of Hydroelectric Power, providing for additional compensation not to exceed \$36,000, providing a cancellation clause, authorizing the drawing and delivery of warrants, and declaring an emergency.

Section 1. The Council finds:

- The Bureau of Hydroelectric Power has entered into Agreement No. 16394 with Mr. H.E. Howe to provide technical project assistance for the Hydroelectric Project.
- The Bureau of Hydroelectric Power requires the continued services of an outside project advisor as directed by Council in Ordinance No. 144169.
- 3. The Bureau of Hydroelectric Power now requires that the present contract be amended to extend the contract period to June 30, 1981 to continue Mr. Howe's technical project assistance and to provide for a monthly retainer of \$1,000 per month plus an hourly compensation rate of \$40.00 per hour, the total not to exceed \$36,000 per year.
- 4. That Section 9 of Agreement No. 16394 is amended to read as follows: "...to its terms. <u>City or Mr. H.E. Howe shall have</u> the right to terminate the contract upon thirty (30) days notice.
- 5. Funds for the outside project advisor are provided in FY 1980-81 budget, BUC 64200003, Object Code 210.

NOW, THEREFORE, the Council directs:

- a. That Agreement No. 16394 with Mr. H.E. Howe is amended to extend the termination date of the contract to June 30, 1981, and provide for a monthly retainer of \$1,000 per month plus an hourly compensation rate of \$40.00 per hour, the total not to exceed \$36,000 per year. Section 9 of the agreement shall be amended to read "...to it terms. City or Mr. H.E. Howe shall have the right to terminate the contract upon thirty (30) days notice.
- b. The Mayor and the Auditor are authorized to draw and deliver warrants payable to Mr. H.E. Howe in an amount not to exceed \$36,000 for professional services rendered in accordance with the agreement when demand is presented and approved by proper authorities.
