

ORDINANCE NO. 150052

An Ordinance creating one position of Deputy City Attorney 2 and abolishing one position of Senior Deputy City Attorney in the Office of City Attorney, authorizing the hiring of John D. Gardner as a Deputy City Attorney 2 at the rate of pay after 2 years, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- (1) The City Attorney has interviewed qualified attorneys to fill a vacant position for a Deputy City Attorney whose assignment will be to represent the City in self-insurance defense litigation.
- (2) The most qualified available attorney is John D. Gardner who has four years' trial experience as a Deputy District Attorney.
- (3) In order to hire John D. Gardner, it will be necessary to compensate him at the Deputy 2 after 2 years pay rate.
- (4) The hiring of John D. Gardner makes it possible to replace a Senior Deputy City Attorney Position with a Deputy City Attorney 2 position.

NOW, THEREFORE, the Council directs:

- (a) One position of Deputy City Attorney 2 is created in the Office of City Attorney (Position Job Class Number 0711).
- (b) One position of Senior Deputy City Attorney is abolished in the Office of City Attorney (Position Job Class Number 0713).
- (c) The Office of City Attorney is authorized to hire John D. Gardner at the Deputy City Attorney 2 after 2 years pay rate effective August 1, 1980, and to compensate him at the after 3 years pay rate when he has completed one year of employment.

Section 2. The Council declares that an emergency exists because filling the vacant position as soon as possible is necessary
