An Ordinance directing changes in the rates of pay for employees represented by the Portland Police Association and the Portland Fire Fighters' Association, Local 43, I.A.F.F., for the period of July 1, 1980 through June 30, 1981, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That the labor agreements between the City of Portland and the Portland Police Association and the Portland Fire Fighters' Association, Local 43, I.A.F.F., provided a formula for a wage adjustment for the period of July 1, 1980, through June 30, 1981.
2. That interim computation of the formula resulted in a wage increase of 8.5% commencing July 1, 1980 implemented by Ordinance #149933.
3. That final computation of the formula based on settlement of the District Council of Trade Unions labor contract results in an additional .75% increase also commencing July 1, 1980.

NOW, THEREFORE, the Council directs:

- a. That the pay rates for the classifications represented by the Portland Police Association and the Portland Fire Fighters' Association, Local 43, I.A.F.F., be fixed in accordance with the salaries listed in Exhibit 1, attached to the original only of this Ordinance.
- b. That the salary rate changes are to be effective as of July 1, 1980.

Section 2. The Council declares that an emergency exists so as not to delay the payment of the recommended pay rates; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
