ORDINANCE No. 150065

An Ordinance adjusting the 1980-81 approved budget for ordinances passed by Council on January 2, March 27, and between April 16 and June 30, 1980, transferring appropriations, creating and abolishing positions and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Certain ordinances were adopted by the City Council on January 2, March 27, and between April 16 and June 30, 1980 which affect the 1980-81 budget.
- 2. The specific ordinances which affect the 1980-81 budget approved by Council on June 25, 1980 are numbered as follows: 148989, 149331, 149459, 149516, 149524, 149679, 149684, 149759, 149762, 149810, 149884, 149919.
- 3. Adjustments should be made to the 1980-81 budget to carry out the intent of these ordinances.

NOW, THEREFORE, the Council directs:

- a. That appropriations be transferred in accordance with Exhibit I attached.
- b. That positions be created and abolished in accordance with Exhibits II and III attached.
- Section 2. Inasmuch as this Ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: That it is necessary to adjust appropriations and positions of the 1980-81 approved budget without delay; therefore, an emergency is hereby declared to exist, and this Ordinance shall be in force and effect from and after its passage by the Council.
