ORDINANCE No. 150066

An Ordinance creating a Special Appropriation Unit, Willamette River Law Enforcement, in the General Fund, transferring appropriation of \$23,700 from Unforeseen Reimbursable Expenditures to the special appropriation, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- Ordinance 149007 authorized an agreement between the City, Multnomah County, and the Port of Portland to provide for a law enforcement program on the Willamette River.
- 2. Ordinance 149236 authorized a purchase agreement contract with the Oregon State Marine Board to provide reimbursement to the City of \$23,700 for the purchase and equipping of one patrol boat.
- 3. The FY 80-81 budget does not include appropriation for this program.
- 4. A special appropriation should be established in the Department of Finance and Administration to track the costs of the program.
- 5. Appropriation in the amount of \$23,700 should be provided by a transfer within the General Fund from Unforeseen Reimbursable Expenditures to the Special Appropriation, Willamette River Law Enforcement.

NOW, THEREFORE, the Council directs:

- a. A Special Appropriation, Willamette River Law Enforcement is hereby created within the General Fund, Department of Finance and Administration.
- b. Appropriation of \$23,700 is hereby transferred within the General Fund from Unforeseen Reimbursable Expenditures to the Special Appropriation, Willamette River Law Enforcement.
- Section 2. The Council declares that an emergency exists, because the appropriation is needed immediately in the account to which it is to be transferred so that there may be no program interruption or administrative delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
