

# ORDINANCE No. 150068

An Ordinance amending the FY 1980-81 City Budget by transferring appropriations to the Human Resources Bureau, AU 380, in the amount of \$12,556, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Pursuant to the FY 1980-81 budget process, \$348,027 was requested from Multnomah County as their equal share of the cost to continue services for the elderly within Portland/Multnomah County under the Area Agency on Aging for the period July 1, 1980, through June 30, 1981.
2. Pursuant to the approved FY 1980-81 budget, Multnomah County has allocated for these services \$360,583 (\$310,583 as their base, plus \$50,000 of one-time-only funds specifically earmarked for the acquisition and development of a senior facility) which is \$12,556 more than what is reflected in the City's budget.
3. It is therefore appropriate that the FY 1980-81 City Budget be amended by transferring appropriations to the Human Resources Bureau, AU 380, in the amount of \$12,556.

NOW, THEREFORE, the Council directs:

- a. That the FY 1980-81 City Budget is hereby amended by transferring appropriations to the Human Resources Bureau, AU 380, in the amount of \$12,556 in the following manner:

GENERAL FUND



Section 2. The Council declares that an emergency exists because any delay in the enactment of this Ordinance will result in the reporting of erroneous financial information; therefore, this Ordinance shall be in force and effect from and after passage by the Council.
