ORDINANCE No. 150068

An Ordinance amending the FY 1980-81 City Budget by transferring appropriations to the Human Resources Bureau, AU 380, in the amount of \$12,556, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Pursuant to the FY 1980-81 budget process, \$348,027 was requested from Multnomah County as their equal share of the cost to continue services for the elderly within Portland/Multnomah County under the Area Agency on Aging for the period July 1, 1980, through June 30, 1981.
- 2. Pursuant to the approved FY 1980-81 budget, Multnomah County has allocated for these services \$360,583 (\$310,583 as their base, plus \$50,000 of one-time-only funds specifically earmarked for the acquisition and development of a senior facility) which is \$12,556 more than what is reflected in the City's budget.
- 3. It is therefore appropriate that the FY 1980-81 City Budget be amended by transferring appropriations to the Human Resources Bureau, AU 380, in the amount of \$12,556.

NOW, THEREFORE, the Council directs:

a. That the FY 1980-81 City Budget is hereby amended by transferring appropriations to the Human Resources Bureau, AU 380, in the amount of \$12,556 in the following manner:

GENERAL FUND

From Unforeseen Reimbursables

Section 2. The Council declares that an emergency exists because any delay in the enactment of this Ordinance will result in the reporting of erroneous financial information; therefore, this Ordinance shall be in force and effect from and after passage by the Council.
