ORDINANCE No. 150073

An Ordinance creating two positions and abolishing three positions within the Training and Employment Division of the Human Resources Bureau, AU 682, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Training and Employment Division (TED) of the City's Human Resources Bureau requires changes to the currently authorized positions within several TED units.
- 2. The Fiscal Unit requires the creation of one position of Typist Clerk (job class 0210).
- 3. The Administrative Unit requires the creation of one position of Clerk II (job class 0112) and the elimination of a Clerk III position (job class 0114); no existing personnel will be affected by this change.
- 4. The Targeted Jobs Demonstration Project within the Planning Unit will not fill the authorized positions of Human Resources Specialist III (job class 7457) and Stenographer Clerk (job class 0220), and these two positions should be abolished.
- 5. This ordinance will result in a net savings of \$17,285 to the TED FY 80-81 budget, at FY 79-80 salary levels, which will be absorbed within the existing appropriations of the Bureau of Human Resources, TED.

NOW, THEREFORE, the Council directs:

a. The following positions are created in the Training and Employment Division of the Human Resources Bureau, AU 682, at salary rates in accordance with the current compensation plan of the City of Portland:
