ORDINANCE NO. 150074

An Ordinance authorizing the execution of a lease amendment with the Yeon Building for the renewal of an office space lease of approximately 15,084 square feet in the Yeon Building, 522 S.W. Fifth Avenue, at an annual rental rate of \$7.25 per square foot for a three year period beginning August 1, 1980, authorizing the drawing and delivery of warrants and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That the Bureau of Human Resources has occupied space in the Yeon Building since August 11, 1977.
- 2. That the Yeon Building has agreed to extend the lease agreement for a three year period at a monthly rental of \$9,113.25.
- 3. That the Bureau of Human Resources has funds in its 1980-81 budget for space rental.
- 4. That the form of lease amendment is an appropriate document for this purpose and has been approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Auditor and the Commissioner of Public Utilities are authorized to enter into an agreement with the Yeon Building for lease of office space for the Bureau of Human Resources, such agreement to be substantially as shown in Exhibit A attached to the original only hereof and by this reference made a part.
- b. Warrants are authorized chargeable to the 1980-81 budget of the Bureau of Human Resources and CETA.
