## ORDINANCE NO. 150076

An Ordinance authorizing the Human Resources Bureau, Training and Employment Division (TED) to accept a Department of Labor CETA Title IV Summer Youth Employment Program (SYEP) grant in the amount of \$1,441,023; reducing the TED budget in the amount of (\$252,381) in FY80-81; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That the Department of Labor has made CETA Title IV-SYEP funds in the amount of \$1,441,023 available to the Training and Employment Division.
2. The grant is for the purpose of operating the Summer Youth Employment Program for the period June 16, 1980, through August 22, 1980.
3. The FY80-81 City budget contains appropriations in the amount of \$1,622,835 for SYEP, based on estimates made during the budget process.
4. This Ordinance will reduce appropriations in the amount of (\$252,381), (\$70,569) of the total having been spent in June, 1980, during the City's FY79-80 fiscal year, and (\$181,812) for a slightly lower than expected award from DOL.
5. There is no match required of the City for this grant.
6. Indirect costs will be charged at a rate of 3% of allowable costs.
7. It is therefore appropriate that the Mayor, on behalf of the City of Portland, accept Grant No. 41-0-010-SYEP in the amount of \$1,441,023 from the Department of Labor, as shown in Exhibit A and make appropriation adjustments as shown.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City, the \$1,441,023 grant awarded by the Department of Labor, as set forth in Exhibit A.
- b. The Finance Officer is hereby authorized to amend the FY80-81 City Budget, reducing resources and requirements as follows:
