## ORDINANCE No. 150078

An Ordinance amending the 1980-81 Compensation Plan ky establishing the compensation rate for the Assistant Emergency Services Coordinator (0908) in the Office of Emergency Services (RU 622) and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That a position of Assistant Emergency Services Coordinator (0908) was created during the 1980-81 budget process.
