ORDINANCE No. 150084

An Ordinance authorizing continuation of the lease/rental agreement no. 18628 with IBM Corporation to furnish computer equipment for the Bureau of Police for Fiscal Year 1980-81 and 1981-82; and authorizing the drawing and delivery of warrants.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Police requires continued use of the computer equipment furnished by the IBM Corporation under lease agreement no. 18628.
- 2. Due to availability schedules for optimum equipment, it is in the best interests of the City and the Bureau to enter into an agreement for a two-year lease on some equipment items and a monthly rental on others.
- 3. The annual cost for the two year period from July 1, 1980 through June 30, 1982 will not exceed \$98,000.
- 4. Funds are available within the FY 80-81 appropriation of the Bureau of Police for this equipment.

NOW, THEREFORE, The Council directs:

- a. The Auditor and Commissioner of Public Safety are authorized to execute rental and lease agreements with IBM Corporation for the subject computer equipment for the period from July 1, 1980 through June 30, 1982.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver warrants, chargeable to the Bureau of Police, AU 100, RU 117, BUC 11700063, Object Code 230; and when demand is presented, approved by the proper authorities.
