ORDINANCE NO. 150097

An Ordinance authorizing the acceptance of Grant No. 81-15 in the sum of \$415,132 through Title III-C-2, Older Americans Act of 1965, as amended, from the State Office of Elderly Affairs, to continue home delivered nutrition services for the elderly under the Human Resources Bureau, AU 380, for the period July 1, 1980, through June 30, 1981; amending the FY 1980-81 City Budget by increasing appropriations in the amount of \$271,878; transferring funds; adjusting line items; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Pursuant to Ordinance No. 149809, approved by Council June 25, 1980, submittal of a grant application in the amount of \$2,319,951 to the State Office of Elderly Affairs was authorized to continue services for the elderly under the Area Agency on Aging for the period July 1, 1980, through June 30, 1981.
- 2. Local match is required in the amount of \$46,126 and will be provided in cash and in the form of in-kind contributions by the nutrition contractor.
- 3. Indirect costs are not available in this grant.
- 4. It is therefore appropriate that the Commissioner-in-Charge and the Auditor accept, on behalf of the City of Portland, Grant No. 81-15 from the State Office of Elderly Affairs in the amount of \$415,132 for the period July 1, 1980, through June 30, 1981, to continue home delivered nutrition services for the elderly as set forth in Exhibit "A"; that the FY 1980-81 City Budget be amended by increasing appropriations in the amount of \$271,878; transferring funds; and adjusting line items.

NOW, THEREFORE, the Council directs:

a. The Commissioner-in-Charge and the Auditor are hereby authorized to accept, on behalf of the City of Portland, Grant No. 81-15 from the State Office of Elderly Affairs in the amount of \$415,132, to continue home delivered nutrition services for the elderly for the period July 1, 1980, through June 30, 1981, as set forth in Exhibit "A"; and the FY 1980-81 City Budget is amended by increasing appropriations in the amount of \$271,878; transferring funds and adjusting line items in the following manner:
