### ORDINANCE No. 150099

An Ordinance transferring \$20,045 within the General Fund from Unforeseen Reimbursable Expenditures to the Bureau of Parks for planting of street trees in the Central Eastside Industrial District, and declaring an emergency.

The City of Portland ordains:

#### Section 1. The Council finds:

- 1. The Bureau of Parks requires \$20,045 additional appropriation within its 1980-81 budget for the purchase and planting of street trees in the Central Eastside Industrial District.
- 2. The Department of Public Works, Bureau of Street and Structural Engineering, has requested the Bureau of Parks to provide these services by interagency agreement as part of the E.D.A. Central Eastside Priority Capital Improvement Project (E.D.A. Project #07-01-02246).
- 3. The additional appropriation should be provided by transfer from Unforeseen Reimbursable Expenditures.

#### NOW, THEREFORE, the Council directs:

a. \$20,045 is transferred within the General Fund from Unforeseen Reimbursable Expenditures to the Bureau of Parks 1980-81 budget as follows:
