ORDINANCE No. 150100

An Ordinance authorizing donation of a golf pass good for one year to the Oregon Open Heart Golf Tournament, August 23 and 24, 1980, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Oregon Open Heart Golf Tournament organizers have requested donation of a golf pass good for free play for one year on any city-owned golf course as a prize for their tournament.
- 2. The donation of such a golf pass for this tournament has been recommended by the Superintendent of Parks and approved by the Commissioner in Charge.

NOW, THEREFORE, the Council directs:

- a. Donation of a golf pass good for one year hereby is authorized to the Oregon Open Heart Golf Tournament to be held on August 23 and 24 1980, at the Tualatin Country Club.
- Section 2. The Council declares that an emergency exists because delay in enactment of this ordinance would cause unnecessary hardship in making arrangements for the Oregon Open Heart Golf Tournament; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
