SUBJECT: <u>IPR/IA Case 2019-C-0144</u>

The above-noted appeal has been set on the City Council Agenda for Thursday, April 8, 2021 at 3:00 p.m.

It is the responsibility of the City Council to determine whether the Portland Police Bureau findings at issue in this appeal are "supported by the evidence." A finding is supported by the evidence "when a reasonable person could make the finding in light of the evidence, whether or not the reviewing body agrees with the finding." City of Portland Code Section 3.21.020 (S).

Issue Presented:

1. Is the Police Bureau's finding of "Exonerated" supported by the evidence with respect to the allegation:

Officer A would not take a vehicle theft report from the Appellant. (PROCEDURE) (Directive 630.61 – Stolen Vehicles)

The Citizen Review Committee (CRC) decided that a "Sustained" finding should have been made as to the allegation. At the conclusion of this hearing, the City Council must decide whether a reasonable person could conclude that a finding of Exonerated is supported by the evidence or not.
