

ORDINANCE No. 150108

An Ordinance creating one (1) position of Heating Inspector I (2130) at the entrance rate of \$11.39 per hour in accordance with the approved City Compensation Plan, and abolishing one (1) position of Building Inspector I (2140) in the Bureau of Buildings, and declaring an emergency.

The City of Portland Ordains:

Section 1. The Council finds:

1. There has been a marked increase in the number of heating permits issued and fees collected over the last fiscal year: fees collected FY 79-80, \$211,677.92; FY 78-79, \$101,727.50: number of permits issued FY 79-80, 5,873; FY 78-79, 2,983.
2. This increased work load, in part, is due to citizens' increased concern in energy conservation which results in installation of alternate means of heating.
3. That in order to provide for the public safety, it will be necessary to provide adequate inspection of these alternate systems.
4. The Bureau of Personnel Services has reviewed this personnel action and recommended the abolishment of one (1) position of Building Inspector I and the creation of one (1) position of Heating Inspector I due to the work load increase in heating and ventilating systems.

NOW THEREFORE, the Council directs:

- a. The following position is created in the Bureau of Buildings with salary rates in accordance with the current compensation plan:

One (1)	2130	Heating Inspector I

- b. The following position in this bureau is abolished:

<u>Number of Positions</u>	<u>Position Job Class No.</u>	<u>Position Classification Title</u>
One (1)	2140	Building Inspector I

Section 2. The Council declares that an emergency exists because the position being created is required immediately in order that the functions of the Bureau of Buildings may be carried out without delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
