ORDINANCE No. 150111

An Ordinance creating one position of Police Records Clerk II within the Bureau of Police, Traffic Division, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That one position of Police Records Clerk II is required by the Traffic Division of the Bureau of Police.
- 21. That for several years and until July 1, 1980, this position was included in the Police Bureau's budget.
- 3. That due to the newness of the Police Bureau's internal decentralized budget process, the above position was inadvertently omitted from the Bureau's FY 80-81 budget.
- That this position is considered very important to the processing of hit and run investigations and the operation of the safety education program.
- That one position of Police Officer will be held vacant by the Police

 Bureau for a period of ten and one-half months to provide the appropriations necessary for the created position.
- 6. That one position of Police Records Clerk II should therefore be created.

NOM, THEREFORE, the Council directs:

- a. That one (1) position of Police Records Clerk II (0151) is hereby created in the Bureau of Police, Traffic Division, with a salary rate in accordance with the current Compensation Plan.
- Section: 2. The Council declares that an emergency exists because the position to be created is immediately required in order that the existing functions may be carried out without delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
